
The tenders complete in all respect and addressed to Dy. Director Health Services (HQ) I/C.SHTO-Nagrota Jammu should reach in this office by or before 11-11-2016 up to 1400 hours and the tenders shall be open on next day.

Terms & Condition:-

1. The rate offerer shall have to quote rates in words as well as in figures.
2. The tenders should be delivered in the office of the undersigned against a proper receipt.
3. The tenders should be accompanied with sample of rubber as mentioned in Annexure to the NIT, so as to check the quality of material.
4. A CDR/FDR amounting to Rs. 3000-00 pledged to Dy. Director Health Services(HQ) I/C.SHTO-Jammu shall have to be enclosed with the tender. However the Govt. agencies are exempted from such security.
5. The tenders with cutting or over writings will be rejected.
6. Rates offered in respect of each item shall remain operative for a period of one year from the date of placement of first supply order.
7. The Items supplied should bear a Guarantee for a period of one year and during the Guarantee period if any defect in the Re-treading material is detected, the same shall have to be replaced free of cost by the successful tenderer.
8. Incentive for local Register SSI units, as per Govt. policy shall be allowed.
9. The successful tenderer shall have to execute the Re-treading of tyres within the time limit prescribed in the supply order.
10. 100% payment shall be made on receipt of Re-treaded tyres and after verification by the Departmental verification committee.
11. The departmental committee reserves the right of accepting or rejecting any or all tenders without assigning any reason thereof.


