Subject: Appointment of Medical Officers in the J&K Health & Family Welfare Department against the newly created 371 posts of Medical Officers for New Type Primary Health Centres (NTPHCs) created vide Government Order No. 585-HME of 2014 dated 17.10.2014-Final notice thereof.

Whereas, the J&K Public Service Commission vide communication No.PSC/DR/Medical Officer/Health/2017 dated 08.02.2018 read with No. PSC/DR/Medical Officer/Health/2017 dated 07.03.2018 from the forwarded selection list of 371 candidates for the post of Medical Officers advertised vide Advertisement Notice No.01-PSC (DR-P) of 2017, dated 27.03.2017.

Whereas, the formal appointment orders were issued by Health & Medical Education Department vide Government Order No. 333-HME of 2018 dated 29.05.2018 in respect of the selected candidates with the directions to report to Directorate of Health Services, Jammu/Kashmir as the case may be; and

Whereas, the appointees were required to report in the respective Department within a period of 21 days from the date of issue of the order failing which their appointment was deemed to have been cancelled without any further notice; and

Whereas, vide communication No's. Est/3/1-133/6136 dated 03.01.2019 from Director, Health Services, Kashmir & DHS-J/ES-3/App/3126 dated 24.12.2018 from Director Health Services, Jammu have intimated that the following five candidates who were appointed as Medical Officer vide Government Order No. 333-HME of 2018 dated 29.05.2018 have not joined in the Directorate of Health Services, Jammu/Kashmir:-
