The appointment of the above candidates shall be subject to the fulfilment of following conditions:-

- A) The appointee(s) shall join in the concerned Directorates of Health Services, Kashmir/Jammu within a period of 21 days from the date of issuance of this order. In case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
- B) The appointee(s) shall be allowed to join in the concerned Directorates of Health Services, Kashmir/Jammu depending upon in which Division they have been posted, as indicated in **Annexure-'A'** to this Order only on production of the following certificates in original:-
1. Academic/Technical Qualification Certificates.
 2. Matriculation/Date of Birth Certificate.
 3. Health Certificate issued by the Standing Medical Board.
 4. Permanent Resident Certificate issued by the Competent Authority.
 5. Certificates from the District Industries Centre(DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been taken by the appointee.
 6. Relevant category certificate(s), (in case of candidates belonging to reserved categories).
 7. Any other certificates/documents as required under rules/norms.
- C) The appointee(s) shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned Directorates of Health Services, Kashmir/Jammu, the candidate(s) shall have no right to claim his/her appointment as Consultant Anesthesiology and his appointment as such shall be deemed to have been cancelled ab-initio without further notice.
- D) If on verification, the certificate(s) produced by the appointee(s) are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
- E) The salary of the appointees shall not be drawn and disbursed unless the satisfactory reports in respect of (C) and (D) above are received in his/her favour.
- F) The appointee shall be on probation for a period of two years as per the Jammu and Kashmir Health and Family Welfare (Gazetted) Service Recruitment Rules, 2013 and confirmation in the service shall be regulated under the provisions of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- G) The inter-se seniority of the appointee(s) shall be strictly as per their merit in the select list.
- H) The appointment of the said candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated: 24.12.2009.
- I) The appointee shall not be allowed to continue with PG/Tenures of Senior Residency/Registrarship/Demonstratorship etc and shall have only one

choice either to opt for appointment or opt out and go for PG/Tenures c
Senior Residency/Registrarship/Demonstratorship etc.




