WHEREAS, Dr. Showkat Ahmad Lone, was appointed as Medical Officer, (Homeopathy) in Indian System of Medicine Department vide Government Order No. 443-HME of 2007 dated 06.07.2007 and joined in the Directorate of ISM on 07.07.2007. The said doctor remained un-authorized absent w.e.f 02.07.2017 to 21.03.2018;

AND WHEREAS, the Director, ISM J&K, Jammu vide letter No. DISM/11 dated 10.10.2017 called explanation of the said doctor with the direction to explain your position within 15 days failing which action under Article 128 J&K CSR Vol-I shall be initiated. The absentee submitted application seeking permission to join on 19.03. 2018, the Director, ISM vide letter No. DISM/Hom/2632-35 dated 09.08.2018 forwarded the case to the Administrative Department for acceptance and period of absence w.e.f 02.07.2017 to 19.03.2018 may be settled under rules;

AND WHEREAS, the Health & Medical Education Department vide letter No. HD/ISM/123/2018 dated 06.09.2018 conveyed Administrative Approval for acceptance of rejoining of Dr. Showkat Ahmad Lone, Medical Officer (Homeopathy);

AND WHEREAS, Directorate of Indian Systems of Medicine, J&K has recommended that the intervening period of un-authorized absence w.e.f 02.07.2017 to 21.03.2018 of Dr. Showkat Ahmad Lone, Medical Officer (Homeopathy) may kindly be treated as leave whatsoever kind is due to him as he is attending his duties regularly from the date he has been allowed to join his duties as his case is genuine in view of his medical condition of psychiatric Disease and was under the treatment for the same during his period of absence;

AND WHEREAS, the instance case has been examined in the department in consultation with Director Finance, Health & Medical Education Department (Chairman, Departmental Designated Committee), and the department while taking a considerate view in the matter, in the interest of patient care, decided the period of un-authorized absence w.e.f 02.07.2017 to 21.03.2018 in respect of Dr. Showkat Ahmad Lone. Medical Officer (Homeopathy) as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies- Non subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any private sector for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of ISM, J&K from the concerned doctor. Besides, the concerned doctor shall furnish Medical fitness certificate from Standing Medical Board. The concerned doctor shall be warned not to leave his place of posting un-authorizedly for any occasion in future, falling which disciplinary action shall be initiated against him without any further notice and the Director, ISM has to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against him and report be furnished within a month.

Now, sanction is hereby accorded to:-

- i. Treat the period of un-authorized absence w.e.f 02.07.2017 to 21.03.2018 in respect of Dr. Showkat Ahmad Lone. Medical Officer (Homeopathy) as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies- Non subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any private sector for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of ISM, J&K from the concerned doctor. Besides, the concerned doctor shall furnish Medical fitness certificate from Standing Medical Board.
- ii. Director, ISM has to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against him and report be furnished within a month.

The concerned doctor shall be warned not to leave his place of posting un-authorizedly for any occasion in future, falling which disciplinary action shall be initiated against him without any further notice.
