Subject: Placement of Medical Officers as In-charge Consultants in various disciplines and posting thereof.

Dated: 09-09.2020

Sanction is hereby accorded to the placement of Medical Officers of J&K Health & Family Welfare (Gazetted) Service, forming **Annexure-A** to this order, as Incharge Consultants in their respective disciplines at the places shown against each, in their own pay and grade on officiating basis, for a period of six months or till the vacancies are filled-up on regular basis on the recommendation of the DPC/PSC, whichever is earlier.

This temporary arrangement shall not confer any preferential right upon these doctors for consideration of promotion as Consultants, as and when, the same is filled up on regular basis under rules and shall be subject to the outcome of writ petition(s), if any, pending consideration before the Court(s) of competent jurisdiction.

It is further ordered that the incumbent shall join their new places of postings within a period of 15 days except those who are undergoing Registrar-ship in GMCs and shall join after completion of the course failing which their placement as Incharge Consultant shall be deemed forfeited by them without any further notice.

All the doctors shall be deemed to have been relieved.
