Sanction is hereby accorded to the release of Rs. 315.26 Lakhs (Rupees Three Crore Fifteen Lakhs Twenty Six Thousands) only, under Capex Budget 2020-21 as UT Share under Centrally Sponsored Scheme "National Programme for Prevention of Cancer, Diabetes, Cardiovascular Diseases and Stroke (NPCDCS) for State Cancer Institute (SCI) at SKIMS Soura, Srinagar in favour of Director, SKIMS, Soura, Srinagar for its utilization during the current financial year (2020-21).

The release of funds shall be subject to the following conditions:

1. Director, SKIMS, Soura, Srinagar shall furnish the physical and financial progress report every month to this Department, which shall be open to on the spot verification.
2. The funds so released shall be utilized for specific purpose after observing all codal procedures/ formalities including Administrative Approval and Technical Sanction from competent authority wherever required.
3. Proper and transparent e-tendering process shall be adopted in the execution of works and purchase of material / supplies / equipments.
4. There shall be no overlapping of funds from any other source including languishing projects funded through JKIDFC and funds shall not be used for clearing any unauthorized past liability.
5. The funds shall not be parked un-necessarily.
6. The funds shall not be available for re-appropriation/ diversion at any level.
7. The funds shall be debited as per the following account classification :


