Sanction is hereby accorded to the temporary appointment of Mr. Jahangir Ahmad Sheikh S/o Late Fata Sheikh (Ex-Safaiwalla) R/o Sahibabad, Achabal, as Class-IV (Safaiwalla) in the Pay Level SL-1 (14800-47100) in the Directorate of Health Services Department, Kashmir in relaxation of prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Director, Health Services Department, Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified by the concerned Head of the Department subsequently:-

- I. Academic Qualification Certificate.
- II. Date of Birth Certificate
- III. Health Certificate from the concerned CMO of District.
- IV. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- V. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- VI. All other relevant documents as are required under SRO-43 of 1994 and other Acts/Rules presently in vogue on the subject.

The appointee shall be initially on probation for a period of two years and his probation shall be governed by the Jammu & Kashmir Probation (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified

vide S.O 192 dated 17.06.2020. His service shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009 issued by the Finance Department.

If, on verification, the documents/certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled abinitio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about his character and antecedents is received from the Inspector General of police, CID, to whom a reference shall be made by the Director, Health Services Department, Kashmir.

If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment, which shall be deemed to have been cancelled abinitio, without any further notice.


