Subject: Settlement of period of absence in favour of Dr. Aakash Jerath, Medical Officer.

WHEREAS, Dr. Aakash Jerath was appointed as Medical Officer in the Health Services Department vide G.O No. 333-HME of 2018 dated 29.05.2018. However, during the period the doctor was undergoing Registrarship in the department of Medicine in Government Medical College, Jammu and vide G.O No. 630-HME of 2018 dated 20.11.2018, among others, sanction was accorded to the extension of joining time upto 08/2020 in favour of the aforesaid doctor for undergoing Registrarship in GMC Jammu;

AND WHEREAS, the aforesaid doctor went for another course i.e. DM (Nephro) from Jawaharlal Institute Post Graduate Medical Education and Research, Dhanvantri Nagar, Puducherry without prior permission of the Administrative Department reason not known and joined the course on 06.01.2020. However, he has resigned the course on 18.09.2020 and joined in Directorate of Health Services, Jammu on 26.09.2020, as he was not allowed/permitted by the Administrative Department;

AND WHEREAS, Directorate of Health Services, Jammu has forwarded his case regarding settlement period of absence to the Administrative Department for issuance of appropriate necessary instructions;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman Departmental Designated Committee), and the Department while taking considerate view in the matter, in the interest of patient care, decided to accept the joining in favour of Dr. Aakash Jerath, Medical Officer, notionally w.e.f 26.09.2020 and monetarily with immediate effect and treat the period of absence we.f. 01.09.2020 to 25.09.2020 in favour of Dr. Aakash Jerath, Medical Officer, as extension in joining time which is without any financial implication and in continuation of Govt. Order No. 630-HME of 2018 dated 20.11.2018 and subject to the condition that the said doctor was not involved in any subversive activities as well as not employed in any Govt./Private Sector & no departmental enquiry is pending against him, for which an affidavit duly authenticated by the 1st Class judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor. Besides, the concerned doctor shall be warned not to leave his place of posting for any

occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice.

Now therefore, sanction is hereby accorded to:-

- i. treat the period of absence w.e.f 01.09.2020 to 25.09.2020 in favour of Dr. Aakash Jerath, Medical Officer, as extension in joining time which is without any financial implication and in continuation of Government Order No. 630-HME of 2018 dated 20.11.2018 and subject to the condition that the said doctor was not involved in any subversive activities as well as not employed in any Govt./Private Sector & no departmental enquiry is pending against him, for which an affidavit duly authenticated by the 1st Class judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor.
- ii. accept the joining in favour of Dr. Aakash Jerath, Medical Officer, notionally w.e.f 26.09.2020 and monetarily with immediate effect.

Besides, the concerned doctor is **warned** not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice.


