Subject: Settlement of period of undergoing higher studies (Fellowship Programme) in favour of Dr. Younis Kamal, Medical Officer/Consultant Orthopedics (now Assistant Professor in Government Medical College Anantnag).

WHEREAS, Dr. Younis Kamal was appointed as Medical Officer in the Health Services, Department vide Government Order No. 335-HME of 2010 dated 17-06-2010 and he reported in Directorate of Health Services, Kashmir on 26-06-2010;

AND WHEREAS, Dr. Younis Kamal, Medical Officer was selected for (Post Doctoral) Fellowship Programme for one year and had requested for permission to undergo same during the year 2015. However, the said doctor left without obtaining prior permission/NOC of the Administrative Department;

AND WHEREAS, subsequently, the aforesaid doctor was appointed as Consultant Orthopedics vide Government Order No.776-HME of 2015 dated 10-12-2015, pursuant to which the said doctor submitted joining report in the Directorate of Health Services Kashmir on 28-12-2015 but preferred to continue the said Fellowship course;

AND WHEREAS, the H&ME Department vide communication No. HME/HRM/120/2016 dated 30-08-2016 asked Director, Health Services, Kashmir to allow Dr. Younis Kamal, Consultant Orthopedics to join the department. Besides, his period of absence shall be decided separately;

AND WHEREAS, there after Dr. Younis Kamal Consultant Orthopedics was appointed as Assistant Professor in the Government Medical Anantnag vide Government Order No. 27-HME of 2019 dated 09-01-2019 and was relieved by Directorate of Health Services, Kashmir vide order No 1364-G of 2019 dated 16-01-2019;

AND WHEREAS, the Directorate of Health Services, Kashmir forwarded his case regarding settlement of period of higher studies w.e.f 23-06-2015 to 29-08-2016 to the Administrative Department for issuance of appropriate necessary instructions.

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter,

decided to treat the period of undergoing higher studies (Post Doctoral) Fellowship Programme w.e.f 23-06-2015 to 29-08-2016 in respect of Dr. Younis Kamal, Medical Officer/Consultant Orthopedics (now Assistant Professor, GMC Anantnag) as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies Non, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Kashmir from the concerned doctor. The concerned doctor shall be warned not to leave his place of posting unauthorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice.

Now therefore, sanction is hereby accorded to:-

- i. Treat the period of undergoing higher studies (Post Doctoral) Fellowship Programme w.e.f 23-06-2015 to 29-08-2016 in respect of Dr. Younis Kamal, Medical Officer/Consultant Orthopedics (now Assistant Professor, Government Medical College, Anantnag) as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies Non, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Kashmir from the concerned doctor.

Further, the concerned doctor is **warned** not to leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice.
