Ex-post facto sanction is hereby accorded to the reimbursement of the medical expenses incurred by Sh. Anil Kumar, Senior Assistant on treatment of his wife in relaxation of Rule 6(1) and 6(A) of the Jammu and Kashmir Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, subject to the following conditions:

- i) Reimbursement of charges shall be restricted to items / procedures admissible under rules for the period of hospitalization and cost thereof is restricted to the rates applicable to such items / procedures at PGI Chandigarh.
- ii) All relevant medical bills / vouchers shall be got verified and countersigned from Competent Medical Authority of the hospital wherefrom treatment has been taken.
- iii) Essentiality certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- iv) Certificate from Competent Medical Authority (Director Health Services / Principal GMC / Other) is obtained to certify that the drugs and services charged are reasonable and to establish the genuineness of the treatment availed in the said hospital.

This issues with the concurrence of Finance Department conveyed vide U. O No. A / 62 (2007) - III - 107 dated 05.02.2020 and General Administration Department's approval conveyed vide O.M No. GDC-69/CM/2020 dated 17.09.2020.


