Subject: Settlement of period of undergoing higher studies (PG in Gynae. & Obstt., Course) in favour of Dr. Beema Akhter, Medical Officer.

WHEREAS, Dr. Beema Akhter, was appointed as Medical Officer in the Health Services Department vide Government Order No.335-HME of 2010 dated 17.06.2010. However at the time of appointment, the said doctor was undergoing PG in Gynae. & Obstt., in GMC, Jammu w.e.f. 02.07.2010 and continued with the same;

AND WHEREAS, Dr. Beema Akhter, Medical Officer after completion of PG in Gynae. & Obstt., course has formally/physically rejoined in the Directorate of Health Services, Jammu on 30.06.2012, and was posted at SDH Surankote. Thereafter, the said doctor was posted at Psy. Hospital GMC, Jammu vide Government Order No. 790-HME of 2019 dated 28.08.2019;

AND WHEREAS, Directorate of Health Services, Jammu has forwarded her case regarding settlement of higher studies to Administrative Department for issuance of appropriate necessary instructions;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman Departmental Designated Committee), and the department while taking considerate view in the matter, in the interest of patient care and has decided to treat the period of undergoing higher studies (PG in Gynae. & Obstt.) at GMC, Jammu w.e.f. 02.07.2010 to 29.06.2012 in respect of Dr. Beema Akhter, Medical Officer as extension in joining time which shall be without financial implications and subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Government/private sector and no departmental enquiry is pending against her, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor. The concerned doctor shall also be warned not leave her place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against her without any further notice. Besides, Directorate of Health Services, Jammu be asked to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against her and report be furnished within a month positively.

Now, therefore, sanction is hereby accorded to:-

- i. treat the period of un-authorized absence w.e.f 02.07.2010 to 29.06.2012, in favour of Dr. Beema Akhter as extension in joining time which shall be without financial implications and subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Government/private sector and no departmental enquiry is pending against her, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Further, the concerned doctor is **warned** not to leave her place of posting for any occasion in future un-authorizedly, for which disciplinary action will be initiated against her without any further notice.

Besides, Directorate of Health Services, Jammu is asked to fix the responsibility who were dealing hands in Directorate for not initiating any action against her and a report be furnished in this regard within a month positively.
