Subject: Settlement of period of undergoing higher studies (DNB Paediatrics course) in favour of Dr. Gowhar Iqbal Wani, Medical Officer.

WHEREAS, Dr. Gowhar Iqbal Wani, was appointed as Medical Officer vide Government Order No. 132-HME of 2014 dated 04.03.2014 and the said doctor joined in the Directorate of Health Services, Jammu on 18.03.2014;

AND WHEREAS, Dr. Gowhar Iqbal Wani, Medical Officer was selected for DNB in Paediatrics at Government Medical General Hospital Sector 16 Chandigarh and he had left w.e.f. 07.03.2016 without obtaining permission/NOC of Administrative Department;

AND WHEREAS, Dr. Gowhar Iqbal Wani, Medical Officer after completion of DNB in Paediatrics from Government Medical General Hospital Sector 16 Chandigarh has rejoined in Directorate of Health Services, Jammu on 16.07.2018 and vide Government Order No. 670-HME of 2018 dated 06.12.2018 among others, the aforesaid doctor was posted at Erstwhile District Hospital Doda;

AND WHEREAS, Directorate of Health Services, Jammu has forwarded the case of the doctor to Administrative Department for issuance of appropriate instructions;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman Departmental Designated Committee), and the department while taking considerate view in the matter, in the interest of patient care, decided to treat the period of undergoing DNB Paediatrics Course at Government Medical General Hospital Sector 16 Chandigarh w.e.f. 07.03.2016 to 15.07.2018, in favour of Dr. Gowhar Iqbal Wani, Medical Officer, as leave whatever kind due expect study leave and remaining period of shortfall be treated as "Dies-Non", subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor. The concerned doctor shall also be warned not leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice. Besides, Directorate of Health Services, Jammu be asked to fix the responsibility who

were dealing hands in Directorate and didn't initiate any action against him and report to be furnished within a month positively.

Now, therefore, sanction is hereby accorded to:-

- i. treat the period of undergoing DNB Paediatrics Course at Government Medical General Hospital Sector 16 Chandigarh w.e.f. 07.03.2016 to 15.07.2018, in favour of Dr. Gowhar Iqbal Wani, Medical Officer, as leave whatever kind due expect study leave and remaining period of shortfall be treated as "Dies-Non" subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Further, the concerned doctor is warned not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action will be initiated against him without any further notice.

Besides, Directorate of Health Services, Jammu is asked to fix the responsibility who were dealing hands in Directorate for not initiating any action against him and a report be furnished in this regard within a month positively.
