AND WHEREAS, the aforesaid doctor, while serving as Medical Officer as well as Consultant Anesthesiology had remained un-authorizedly absent on following spells of time on the reasons shown against each spell:-

AND WHEREAS, the aforesaid doctor is presently posted at CHC Rajpora
\* Pulwama against the available post of Consultant Anesthesia and the Directorate of Health
Services, Kashmir forwarded his case regarding settlement of absence to the
Administrative Department for issuance of appropriate instructions;

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, in the interest of patient care, decided to treat the period of spells of un-authorized absence (01-05-2006 to 30-11-2006, 01-02-2007 to 09-07-2008 & 15-03-2019 to 05-08-2019) in respect of Dr. Mohd Yousuf Tak, as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies-Non and subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by the Ist Class Judicial Magistrate shall be obtained by the Directorate of Health Services

Kashmir from the concerned doctor. The concerned doctor be warned not to leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice. Besides, Director, Health Services, Kashmir be asked to fix the responsibility who were dealing hands in Directorate and failed to initiate any action against him during his absence and report to be furnished within a month.

Now, therefore, sanction is hereby accorded to:-

i. Treat the period of following spells of un-authorized absence in respect of Dr. Mohd Yousuf Tak, Consultant Anesthesia, as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies-Non and subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by the Ist Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor:-
