**GOVERNMENT ORDER NO. 769 -JK(HME) OF 2020
D A T E D : 01 - 10 - 2020**

WHEREAS, vide Government Order No. 634-JK(HME) of 2020 dated 28.08.2020, **Dr. Ishtiyaq Ahmad Dar**, was engaged as Assistant Professor in the discipline of Radiotherapy in Government Medical College, Baramulla on academic arrangement basis under SRO-24 of 2019 dated 10.01.2019;

AND WHEREAS, the Principal, Government Medical College, Baramulla, vide letter No. GMC/Bla/Acad/2007-2011 dated 23.09.2020, reported that Dr. Ishtiyaq Ahmad Dar sent his joining report to the office of the Principal, Government Medical College, Baramulla, without physically joining in the said Medical College within the stipulated time of twenty one (21) days;

AND WHEREAS, the Principal, Government Medical College, Baramulla has further reported that after submitting his joining report, Dr. Ishtiyaq Ahmad Dar failed to attend the College physically and has requested for termination of the engagement of said doctor as Assistant Professor in the discipline of Radiotherapy in Government Medical College, Baramulla on academic arrangement basis;

AND WHEREAS, the matter has been examined in the Health and Medical Education Department and it has been concluded that mere submission of joining report without physically joining and attending the duties cannot be construed as joining the duties under rules. It has accordingly been decided to cancel the engagement of Dr. Ishtiyaq Ahmad Dar, Assistant Professor in the discipline of Radiotherapy in Government Medical College, Baramulla.

Now, therefore, the engagement of Dr. Ishtiyaq Ahmad Dar, ordered vide Government Order No. 634-JK(HME) of 2020 dated 28.08.2020, as Assistant Professor in the discipline of Radiotherapy, in Government Medical College, Baramulla, is hereby terminated.
