Subject: Notice to the un-authorized absent doctors – compliance/posting thereof.

Government Order No. 647 -JK(HME) of 2020
Dated: 01 -09-2020

WHEREAS, the Directors, Health Services, Kashmir vide communication No. Est/3/1-133/244 dated 22.01.2020 & No. Est/3/1-133/1183 dated 19.05.2020 has forwarded the list/details of such doctors who remained un-authorizedly absent from duties;

AND WHEREAS, the Director, Health Services, Kashmir vide No. Est/3/1-133/2646-47 dated 17.12.2019 had already served notices to these un-authorizedly absent doctors which was also published in local daily Kashmir Uzma in its edition dated 20.12.2019 giving them opportunity to report back to their duties;

AND WHEREAS, after examination of the cases in the Department, it was decided to give last and final opportunity to these un-authorizedly absent doctors for reporting back in the Directorate of Health Services, Kashmir within a period of 15 days positively;

AND WHEREAS, vide communication No. HME/HRM/33/2014 dated 22.04.2020, among others, last and final opportunity was given to the un-authorizedly absent doctors, to report back in Directorate of Health Services, Kashmir within a period of 15 days, failing which it shall be presumed that they have nothing to say in their defense and proceedings as warranted under Rules;

AND WHEREAS, the Director, Health Services, Kashmir vide communication No. Est/3/1-133/1183 dated 19.05.2020 and No. Est/3/1-133/1317 has again submitted that the following doctors have reported in the Directorate;

AND WHEREAS, on the basis of information received from the Director, Health Services, Kashmir, the cases of these doctors have been examined in the

Department and in the interest of patient care, it has been decided that these 03 doctors, who have reported in the Directorate of Health Services, Kashmir in compliance to the notices served upon them, be posted against the places proposed by Director, Health Services Kashmir, subject to the condition that the period of their absence shall be decided separately. Besides, these doctors shall be warned to remain cautious/careful in future for which disciplinary action shall be initiated against them;

Now, therefore, sanction is hereby accorded to the posting of following doctors to the places indicated against each:-
