In terms of Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Dr. Robindera Kour (MS Surgery), Medical Officer, Government Hospital Sarwal, Jammu for undergoing higher study course (i.e. Fellowship in Colorectal Surgery) at SKIMS Soura, Srinagar for a period of one year (out of two years) w.e.f. 17-08-2020, in the first instance, subject to the following conditions:-

- i. The work load on account of her study leave is managed through internal arrangement;
- ii. The doctor shall have no superior claim over her seniors for consideration of promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. The stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in her salary and;
- v. The doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.


