As recommended by the Selection Committee, sanction is hereby accorded to the engagement of **Dr. Imtiyaz Ahmad Khan S/O Hamid Ullah Khan R/O 475-Midoora, Awanitpora**, as Lecturer in the discipline of Radio Diagnosis & Imaging in Government Medical College, Srinagar, on academic arrangement basis, in terms of the Jammu & Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified in terms of S.O 364 of 2020 dated 27.11.2020, for a period of one year or till the post is filled up on regular basis, whichever is earlier.

Dr. Imtiyaz Ahmad Khan shall report to the Principal, Government Medical College, Srinagar for joining within a period of 21 days from the date of issuance of this order, failing which his engagement as such shall stand cancelled without any further notice.

The arrangement shall be purely on temporary basis for teaching purposes only and shall not confer upon him any special claim/ right for appointment against the post on regular basis as and when the same is made under rules.

Dr. Imtiyaz Ahmad Khan shall have to execute an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 dated 27.11.2020. His engagement shall be regulated under other terms and conditions as specified in the said SO. The engagement so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selection/promotion is made in accordance with the rules of recruitment governing the respective posts, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
