The appointee shall report to the Principal Government Medical College Jammu within 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/ certificates in original to be verified subsequently:-

- Academic Qualification Certificate.

- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- Dependent Certificate issued by the Assistant Commissioner Revenue.
- vi. All other relevant documents as are required under SRO- 43/1994.
- vii. No loan certificate under self Employment Scheme from DIC concerned and Employment Department.

The appointment of the appointee shall further be subject to the following conditions:-

a) That he shall give an undertaking in the shape of an affidavit to the effect that:-



- In case adverse report about his character and antecedents is received i. from the Inspector General of Police (CID), J&K, to whom a reference shall be made by the Principal, Government Medical College, Jammu, he shall have no right to claim his appointment as Class-IV (Orderly) and his appointee, as such shall be deemed to have been cancelled ab-initio.
- If on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/ forged, the claim of the ii. appointment as Class-IV (Orderly) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (i) and (ii) above are received in his favour.
- The appointee shall be initially on probation for a period of two years. His pay c) during the period of probation shall be regulated in terms of S.O 192 of 2020 dated 17.06.2020.
- The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009-dated 24.12.2009.
- If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall e) be deemed to have been cancelled ab-initio without any further notice.
