Subject: Cancellation of Engagement of Associate Professor in the discipline of ENT on academic arrangement basis in Government Medical College, Kathua.

**WHEREAS**, vide Government Order No. 236-HME of 2019 dated 27.02.2019, **Dr. Rakesh Sharma**, was engaged as Associate Professor in the discipline of ENT in Government Medical College, Kathua on academic arrangement basis under SRO-24 of 2019 dated 10.01.2019;

**AND WHEREAS**, the Principal, Government Medical College, Doda vide Advertisement Notice No. 2063/GMCD/Adm/2020 dated 31.08.2020, advertised various faculty posts, which were vacant in different disciplines;

**AND WHEREAS**, among others, **Dr. Rakesh Kumar** applied for engagement on the post of Professor in the discipline of ENT;

**AND WHEREAS**, the Selection Committee as provided under SRO-24 of 2019 dated 01.10.2019 regarding engagement of faculty on academic arrangement basis in its meeting held on 13.10.2020 found **Dr. Rakesh Kumar** eligible for engagement on the post of Professor and accordingly recommended him for engagement on the post of Professor in the discipline of ENT in Government Medical College, Doda;

**AND WHEREAS**, in light of the above circumstances, the case has been examined in the Department and it has been decided to cancel the engagement of **Dr. Rakesh Kumar** as Associate Professor in the discipline of ENT in Government Medical College, Kathua, before issuance of his engagement order as Professor in the discipline of ENT in Government Medical College, Doda.

**Now, therefore**, the engagement of **Dr. Rakesh Sharma** as Associate Professor in the discipline of ENT in Government Medical College, Kathua, ordered vide Government Order No. 236-HME of 2019 dated 27.02.2019, is terminated.
