As recommended by the Selection Committee, sanction is hereby accorded to the engagement of **Dr. Mohammad Maqbool Lone S/O Mr. Ab. Khaliq Lone R/O Village Krusan Lolab, Kupwara**, as Professor in the discipline of Radiotherapy in Government Medical College, Baramulla, on academic arrangement basis, in terms of SRO-24 of 2019 dated 10.01.2019, for a period of three years or till the post is filled up on regular basis or till he attains the age of 70 years, whichever is earliest.

Dr. Mohammad Maqbool Lone shall have to execute an agreement with the Government on the prescribed form in terms of SRO-24 of 2019 dated 10.01.2019. His engagement shall be regulated under other terms and conditions as specified in the said SRO.
