WHEREAS, Dr. Gowhar Abass Khan was appointed as Medical Officer in the Health Services, Department vide Government Order No 710-HME of 1997 dated 12-08-1997 and he has submitted joining report in Directorate of Health Services, Kashmir on 19-08-1997;

AND WHEREAS, the aforesaid doctor was placed under suspension vide Government Order No 487-HME of 2016 dated 31-08-2016 and was attached to Directorate of Health Services, Kashmir. Later on the aforesaid doctor was re-instated vide Government Order. 361-HME of 2017 dated 11-07-2017 and was informed that further necessary action in the matter under Rule 30 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 as well as decision regarding settlement of the suspension period shall be taken on later;

AND WHEREAS, after the issuance of suspension order the aforesaid doctor didn't join at Directorate of Health Services, Kashmir but aforesaid doctor joined later on i.e 18-11-2016. Further Directorate of Health Services, Kashmir vide communication No. Est-3/1-133/263 dated 20-01-2018 has informed that the aforesaid doctor has joined in the Directorate of Health Services, Kashmir on 18-11-2016 and was attached up-to 28-10-2017. During the said period the aforesaid doctor was attending the office of Directorate of Health Services, Kashmir;

AND WHEREAS, however, the HRM section of H&ME department has intimated that there is no case/enquiry pending in favour of Dr. Gowhar Abass Khan, Medical Officer;

AND WHEREAS, Directorate of Health Services Kashmir forwarded his case regarding settlement of suspension period to the Administrative Department for issuance of appropriate necessary instructions.

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health

and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, decided to Treat the period of un-authorized absence (un-described purposes) w.e.f 31-08-2016 to -17-11-2016 in respect of Dr. Gowhar Abass Khan, Medical Officer, as Dies-Non, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the Ist Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor. Besides, may treat the period of suspension w.e.f 18-11-2016 to 28-10-2017 in respect of Dr. Gowhar Abass Khan, Medical Officer, as on duty subject to condition that he has regular attendance in the Directorate of Health Services Kashmir which shall be certified by the concerned Controlling Officer. The concerned doctor shall be warned to leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice.

Now therefore, sanction is hereby accorded to:-

- i. Treat the period of un-authorized absence (un-described purposes) w.e.f 31-08-2016 to -17-11-2016 in respect of Dr. Gowhar Abass Khan, Medical Officer, as Dies-Non, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by the Ist Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor.
- ii. Treat the period of suspension w.e.f 18-11-2016 to 28-10-2017 in respect of Dr. Gowhar Abass Khan, Medical Officer, as on duty subject to condition that he has regular attendance in the Directorate of Health Services Kashmir which shall be certified by the concerned Controlling Officer.

Besides, the concerned doctor is **warned** to leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice.
