As recommended by the Selection Committee, sanction is hereby accorded to the engagement of **Dr. Sujata Gupta D/O Mr. Bal Krishan Gupta R/O Rehari Colony, Jammu** as Epidemiologist (Assistant Professor) in the discipline of Community Medicine in Government Medical College, Kathua, on academic arrangement basis, in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2019, notified vide SRO-24 of 2019 dated 10.01.2019, for a period of one year or till the post is filled up on regular basis, whichever is earlier.
