**Subject:** Settlement of period of undergoing higher studies (DNB in Gynea & Obst) in favour of Dr. Shazia Anjum, Medical Officer.

WHEREAS, Dr. Shazia Anjum was appointed as Medical Officer in the Health Services, Department vide Government Order No 132-HME of 2014 dated 04-03-2014;

AND WHEREAS, the said doctor has been selected for DNB Gynea & Obst at Hindu Rao Medical College, New Delhi w.e.f 17-04-2018 and left without obtaining prior permission/NOC of the Administrative Department;

AND WHEREAS, after the completion of the said course, the said doctor has rejoined in Directorate of Health Services, Jammu on 16-06-2020;

AND WHEREAS, the Directorate of Health Services, Jammu has forwarded her case regarding rejoining/settlement of period of unauthorized absence to the Administrative Department for instructions and orders.

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, decided to accept the re-joining of Dr. Shazia Anjum, Medical Officer, notionally i.e. 16-06-2020 and monetarily with immediate effect and to treat the period of undergoing higher studies (DNB in Gynea & Obst) at Hindu Rao Medical College, New Delhi w.e.f 17-04-2018 to 15-06-2020 in respect of Dr. Shazia Anjum, Medical Officer as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies Non, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against her, for which an affidavit authenticated by the Ist Class Judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor. The concerned doctor shall be warned not to leave her place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against her without any further notice. Director, Health Services, Jammu is asked to fix responsibility who were dealing hands in

Directorate and didn't initiate any action against un-authorized absentee and report be furnished within a month positively.

Now therefore, sanction is hereby accorded to:-

- i. accept the re-joining of Dr. Shazia Anjum Medical Officer, notionally i.e. 16-06-2020 and monetarily with immediate effect.
- ii. Treat the period of undergoing higher studies (DNB in Gynea & Obst) at Hindu Rao Medical College, New Delhi w.e.f 17-04-2018 to 15-06-2020 in respect of Dr. Shazia Anjum, Medical Officer as leave whatever kind due except study leave and remaining period of shortfall be treated as Dies Non, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against her, for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor.

Besides, the concerned doctor is **warned** not to leave her place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against her without any further notice.

Further, Director, Health Services, Jammu is asked to fix responsibility who were dealing hands in Directorate and didn't initiate any action against un-authorized absentee and report be furnished within a month positively.
