Subject: Settlement of period of undergoing higher studies (PG in Anaesthesiology) in favour of Dr. Updesh Kumar, Medical Officer (now Lecturer).

WHEREAS, Dr. Updesh Kumar was appointed as Medical Officer in the Health Services Department vide Government Order No. 212-HME of 2007 dated 28-03-2007. However, at the time of appointment, the concerned doctor was undergoing MD Anaesthesia and preferred to continue the same at Government Medical College Jammu w.e.f 13-04-2007;

AND WHEREAS, after the completion of course, the aforesaid doctor has formally/physically joined in Directorate of Health Services, Jammu on 04-06-2009;

AND WHEREAS, the aforesaid doctor was appointed as Lecturer at Government Medical College, Jammu vide Government Order No. 375-HME of 2018 dated 19-06-2018;

AND WHEREAS, the said Directorate forwarded his case regarding settlement of period of higher studies to the Administrative Department for issuance of appropriate necessary instructions;

AND WHEREAS, the issue with regard to settlement of the intervening period was examined in consultation with Director Finance, Health and Medical Education Department (Chairman, Departmental Designated Committee) and the Department while taking considerate view in the matter, decided to treat the period of undergoing higher studies (MD Anth) at Government Medical College Jammu, w.e.f 13-04-2007 to 03-06-2009 in respect of Dr. Updesh Kumar, Medical Officer (now Lecturer) as extension in joining time which shall be without financial implications, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by the Ist Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor. The concerned doctor shall be warned not to leave his place of posting unauthorizedly for any occasion in future, failing which disciplinary action shall

be initiated against him without any further notice. Director, Health Services, Jammu be asked to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against him and report to be furnished within a month.

Now therefore, sanction is hereby accorded to:-

- i. Treat the period of undergoing higher studies (MD Anth) at Government Medical College Jammu, w.e.f 13-04-2007 to 03-06-2009 in respect of Dr. Updesh Kumar, Medical Officer (now Lecturer) as extension in joining time which shall be without financial implications, subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any Govt./private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by the 1st Class Judicial Magistrate shall be obtained by the Director, Health Services, Jammu from the concerned doctor.

Further, the concerned doctor is **warned** not to leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice.

Besides, Director, Health Services, Jammu is asked to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against him and report to be furnished within a month.


