WHEREAS, the Principal, Government Medical College, Srinagar, has forwarded communication No. Acad/8870/MC dated 07.12.2020, with the subject "Misconduct of HOD Ophthalmology, Government Medical College, Srinagar" wherein, it has inter-alia been stated that while conducting interview of the eligible candidates for adjustment/appointment of Registrar against the available vacancy (s) in the Department of Ophthalmology, barring HOD Ophthalmology all other members of the Selection Committee were of consensus that Dr. Arsalan Un Nisa figures at Serial No. 01 in the merit list, which the concerned HOD did not agree reflecting illogical reasons and refused to sign the final merit list;

AND WHEREAS, the Principal, Government Medical College, Srinagar has also stated that in view of the frequent complaints received against the HOD Ophthalmology, non-compliance of orders, which creates insubordination, disobedience and disrespect of the chair among the subordinate staff and in order to stop harassment/annoyance of the genuine candidates/students in Department of Ophthalmology and smooth functioning of the Department, a departmental enquiry may be initiated against the HOD;

AND WHEREAS, a complaint has also been lodged by one Dr. Parvez Ahmad Bhat R/o Saimoh Tral, Pulwama (7006373293) alleging therein that the Head of the Department of Ophthalmology, Government Medical College, Srinagar has been found to have selected candidates for the post of Registrar out of merit;

AND WHEREAS, the matter has been examined in the Department and it has been decided to conduct an enquiry into the matter by appointment of an Inquiry Officer.

Now, therefore, sanction is hereby accorded to the appointment of Dr. Waseem Qureshi, Registrar Academics, Government Medical College, Srinagar as Inquiry Officer to conduct enquiry into the matter. The Inquiry Officer shall submit his report to the Administrative Department within a period of 20 days from the date of issuance of the order.

Mtr. Shaheena Khan (KAS), Personnel Officer, Government Medical College, Srinagar shall act as the Presenting Officer on the enquiry.
