Subject:- Repatriation of Dental Surgeons to concerned Directorate of Health Services, Jammu/Kashmir.

Ref:- Government Order No. 652-JK(HME) of 2020 dated 03-09-2020 & Government Order No. 685-JK(HME) of 2020 dated 10-09-2020 issued by the H&ME Department.

WHEREAS, the Health and Medical Education Department vide Government Order No. 652-JK(HME) of 2020 dated 03-09-2020 transferred Dr. Anjum Jalal, Dental Surgeon from PHC Saidaware Kulgam and posted at Government Dental College Srinagar on the standard terms & conditions of deputation in the interest of patient care;

AND WHEREAS, the Health and Medical Education Department vide Government Order No. 685-JK(HME) of 2020 dated 10-09-2020 transferred Dr. Karam Singh, Dental Surgeon from Rajiv Gandhi Hospital, Gangyal Jammu and posted at Indira Gandhi Government Dental College, Jammu on the standard terms & conditions of deputation in the interest of patient care;

AND WHEREAS, the Principal, Indira Gandhi Government Dental College, Jammu vide communication No. IGGDCJ/Estt/GD/1768-70 dated 29-09-2020 has intimated that there is no post of Dental Surgeon vacant against which the salary of the incumbent can be drawn and also requested to intimate the mode of drawl of salary/ or a post of Dental Surgeon may be transferred to Indira Gandhi Government Dental College, Jammu for drawl of pay dues to Dr. Karam Singh, Dental Surgeon;

AND WHEREAS, accordingly, the H&ME Department vide communication No. HD/Gaz/TF-16/2016 dated 05-10-2020 conveyed Director, Health Services, Jammu/Kashmir to transfer any Dental Surgeon(s) having completed his/her maximum period of deputation/stay at Government Dental College & Hospital, Srinagar and Indira Gandhi Government Dental College & Hospital Jammu immediately enabling the concerned DDO's to draw the salaries in respect of Dr. Anjum Jalal, Dental Surgeon and Dr. Karam Singh Dental Surgeon;

AND WHEREAS, the aforesaid transfer of Dental Surgeons having mature stay in Government Dental Colleges could not be finalized at the level of Directorate of Health Services, Jammu/Kashmir;

AND WHEREAS, the proposal was mooted by the Health and Medical Education Department for release of salary by the concerned Director, Health Services, Jammu/Kashmir on monthly attendance basis in

favour of Dr. Karam Singh Dental Surgeon and Dr. Anjum Jalal, Dental Surgeon against available posts viz, PHC Thakar Kote, District Reasi and PHC Sultan Taki, Block Uri due to inability shown by the concerned Principals of Government Dental Colleges Jammu/Srinagar;

AND WHEREAS, the competent authority in Health and Medical Education Department, didn't agree the proposal and passed specific instructions for implementation.

Now therefore, it is hereby ordered that:-

- i. The posting/deputation arrangement made in respect of Dr. Anjum Jalal, Dental Surgeon and Dr. Karam Singh, Dental Surgeon, pursuant to Government Order No. 652-JK(HME) of 2020 dated 03-09-2020 & Government Order No. 685-JK(HME) of 2020 dated 10-09-2020 respectively, shall be deemed cancelled w.e.f 01-01-2021 and both the Dental Surgeons shall report to concerned Directorate of Health Services, Kashmir/ Jammu for further posting.
- ii. Authorize Director, Health Services, Kashmir/ Jammu to draw salaries upto 12/2020 in respect of Dr. Anjum Jalal, Dental Surgeon and Dr. Karam Singh Dental Surgeon against clear vacancies of Dental Surgeons viz, PHC Sultan Taki, Block Uri and PHC Thakar Kote, District Reasi respectively.
- iii. The concerned Director, Health Services, Kashmir/ Jammu shall immediately submit formal posting proposal in respect of both the Dental Surgeons against the clear vacancies in Health Services Department.
