
WHEREAS, on the recommendations of J&K Public Service Commission conveyed vide their various communications, the following candidates were appointed as Lecturers in the discipline of Orthopedics in Government Medical College, Jammu in terms of various Government Orders:-

AND WHEREAS, while preparing the proposals of the eligible Lecturers for placement as Assistant Professors in the discipline of Orthopedics, Government Medical College, Jammu, against two available vacancies as per available Roster (Roster Point No. 3-SC & 4-RBA), the Principal, GMC Jammu forwarded the proposal in respect of Dr. Bias Dev (SC) only for consideration for placement against the SC slot. Accordingly, Dr. Bias Dev was placed as I/C Assistant Professor in the discipline of Orthopedics in GMC, Jammu against the available Roster Point No. 03 (meant for SC category) vide Government Order No.681-HME of 2014 dated 26.12.2014;

AND WHEREAS, the next available post of Assistant Professor was not filled-up due to non-availability of an eligible Lecturer under RBA category (Roster Point 4-RBA) at that point of time. The Principal, GMC Jammu subsequently forwarded the proposal of Dr. Mohammad Farooq Bhat, on 04.04.2016, for placement as Assistant Professor on Incharge basis. The placement of Dr. Mohammad Farooq Bhat was not considered due to the fact that Dr. Farid Hussain appointed as Lecturer under RBA category in the year 2013 (on 06.02.2013) had become eligible by that time for consideration for promotion to the post of Assistant Professor against the available RBA slot. However, no proposal for placement on the post of Assistant professor was received from the Principal, Government Medical College, Jammu in respect of Dr. Farid Hussain;

AND WHEREAS, in the year 2018, Dr. Farid Hussain (RBA) submitted an affidavit on 22.11.2018 wherein he solemnly affirmed on oath that he has no objection if the RBA slot allocable to him is de-reserved and offered to a candidate from general quota.



AND WHEREAS, vide letter No. GMCJ/ES-1/1702 dated 28.01.2019, the Principal, GMC, Jammu forwarded a proposal for placement of Dr. Mohammad Farooq Bhat as I/C Assistant Professor. The proposal was processed in the Department and accordingly, Dr. Mohammad Farooq Bhat was placed as I/C Assistant Professor vide Government Order No. 588-HME of 2019 dated 20.06.2019 against Roster Point 4 (meant for RBA), which was treated as de-reserved.

Now, therefore, in light of the circumstances explained above, the final seniority list of the Lecturers in the discipline of Orthopedics, Government Medical College, Jammu, is notified as under:-
