WHEREAS, Dr. Bharat Bhusan was appointed as Medical Officer in the Health Services Department vide Government Order No. 702-HME of 2001 dated 04-10-2001. However, at that time, the said doctor was pursuing Post Graduation (Surgery) from GMC Jammu and submitted his joining report through Principal GMC Jammu vide communication No.GMC/FAC/PG/1134 dated 22-10-2001.

AND WHEREAS, the said doctor after completion of his course reported to Directorate of Health Services, Jammu on 21-02-2004. Subsequently, the doctor was appointed as Consultant Surgeon vide Government Order No.290-HME, of 2011 dated 07-06-2011 and joined in Directorate of Health Services, Jammu on 10-06-2011;

AND WHEREAS, Directorate of Health Services, Jammu has submitted the case of the doctor for instructions of the administrative department with regard to acceptance of rejoining/settlement of period in respect of the aforesaid doctor;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman, Departmental Designated Committee), and the department while taking a considerate view in the matter, in the interest of patient care, decided to treat the period of undergoing Post Graduation (Surgery) at GMC Jammu w.e.f 22-10-2001 to 20-02-2004, in favour of Dr. Bharat Bhushan, Medical Officer (Now Consultant Surgeon), as extension in joining time which is without any financial implication. The concerned doctor shall be warned not to leave his place of posting unauthorizedly for any occasion in future for which disciplinary action shall be initiated against him without any further notice. Besides, Directorate of Health Services, Jammu be asked to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against her and report to be furnished within a month.

Now, therefore, sanction is hereby accorded to treat the period of undergoing Post Graduation (Surgery) at GMC Jammu w.e.f 22-10-2001 to 20-02-2004, in respect of Dr. Bharat Bhushan, Medical Officer (Now Consultant Surgeon), as extension in joining time which is without any financial implication.
