Sanction is hereby accorded to the grant of provisional NOC/ Permission in favour of Iqra Para-Medical Institute Kitchama Sheeri Baramulla, for a period of one year to start the following Paramedical training courses with intake capacity as indicated against each stream:-

The provisional No Objection Certificate is granted subject to the following terms & conditions:-

- i. Subject to the fulfillment of provisions laid down in the J&K Paramedical Council Act, 2014.
- ii. No capitation fee will be charged by the Institute.
- iii. The permission shall be subject to any policy on the subject, which the Government may sanction in future for regulation of these institutes.
- iv. Eligibility of candidates for admission to the above courses shall be made on merit basis as per the provisions laid down by the Government from time to time through J&K Board of Professional Entrance Examinations.
- v. The, J&K, Paramedical Council shall conduct inspection of the institute, periodically, to monitor and assess the

adequacy of infrastructure in relation to the number of trainees.

- vi. An amount of Rs. 5000/- per trainee per session be charged by the institute on account of providing hospital facility, and the amount so received, be utilized for Hospital Development fund, of the Hospital to which the institute is attached.
- vii. For any lapse on the part of any student/students resulting in loss/damage to equipments/ chemicals etc in the Hospital, the institute shall be responsible for it. An undertaking to this effect be executed by the management for the institution with the Medical Superintendent of the Hospital.
- viii. J&K Paramedical Shall conduct examination of the trainees on the same pattern as in the case of trainees in AMT/ANMT School in the UT.
