**Government Order No. 597 -JK(HME) of 2020**

WHEREAS, Dr. Eijaz Ahmad Bhat, was appointed as Medical Officer vide Government Order No. 592-HME of 2011 dated 28.10.2011 and the said doctor joined in the Directorate of Health Services, Kashmir on 04.11.2011. However during the period the said doctor was undergoing Sr. Residency at SKIMS Soura and continued with the same;

AND WHEREAS, Dr. Eijaz Ahmad Bhat, Medical Officer after completion of Sr. Residency has rejoined in Directorate of Health Services, Kashmir on 07.07.2014;

AND WHEREAS, the said doctor while working in Block Lar Ganderbal approached to Directorate of Health Services, Kashmir with an application stating therein that he has to appear in the counseling being conducted by National Board for DNB Super Speciality and requested for NOC in his favour, however, he left on its own without any approval of the Administrative Department;

AND WHEREAS, Dr. Eijaz Ahmad Bhat, Medical Officer after completion of DNB course has rejoined in Directorate of Health Services, Kashmir on 25.04.2018 and the said Directorate has forwarded the case of the doctor to Administrative Department for further instructions. Meanwhile pending instructions from Administrative Department the services of the doctor were utilized at District Hospital Ganderbal by Directorate of Health Services, Kashmir;


AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman Departmental Designated Committee), and the department while taking considerate view in the matter, in the interest of patient care, decided to treat the period of undergoing Sr. Residency at SKIMS Soura, w.e.f.



04.11.2011 to 06.07.2014, in favour of Dr. Eijaz Ahmad Bhat, Medical Officer, as extension in joining time which is without any financial implication. Period of undergoing DNB Resident in Neurology at Batra Hospital and Medical Research w.e.f. 12.03.2015 to 12.03.2018 in respect of Dr. Eijaz Ahmad Bhat, Medical Officer be treated as "Dies-Non" subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any private sector for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor. Besides, action taken by Directorate of Health Services, Kashmir by utilizing his services on rejoining be also confirmed. The concerned doctor shall also be warned not leave his place of posting un-authorizedly for any occasion in future, failing which disciplinary action shall be initiated against him without any further notice. Besides, Directorate of Health Services, Kashmir be asked to fix the responsibility who were dealing hands in Directorate and didn't initiate any action against him and report to be furnished within a month positively.

Now, therefore, sanction is hereby accorded to:-

- i. treat the period of undergoing Sr. Residency at SKIMS Soura, w.e.f. 04.11.2011 to 06.07.2014, in favour of Dr. Eijaz Ahmad Bhat, Medical Officer, as extension in joining time which is without any financial implication.
- ii. treat the period of undergoing DNB Resident in Neurology at Batra Hospital and Medical Research w.e.f. 12.03.2015 to 12.03.2018 in respect of Dr. Eijaz Ahmad Bhat, Medical Officer as "Dies-Non" subject to the condition that the said doctor was not involved in any subversive activities as well as was not employed in any private sector for which an affidavit authenticated by the 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor. Besides, action taken by Directorate of Health Services, Kashmir by utilizing his services on rejoining be also confirmed.
- iii. the concerned doctor is **warned** not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action will be initiated against him without any further notice.



Besides, Directorate of Health Services, Kashmir is asked to fix the responsibility who were dealing hands in Directorate for not initiating any action against him and a report be furnished in this regard within a month positively.


