
WHEREAS, Dr. Parvaiz Ahmad Shah, was appointed as Medical Officer vide Government Order No. 335-HME of 2010 dated 17.06.2010 and the said doctor joined in the Directorate of Health Services, Kashmir on 28.06.2010;

AND WHEREAS, Dr. Parvaiz Ahmad Shah, Medical Officer had been selected for undergoing DNB in Gastroenterology at Apollo Hospital Kolkata w.e.f. 12.03.2015 and the said Directorate forwarded his case to Administrative Department for further instructions. Accordingly, NOC was conveyed by Administrative Department in favour of the doctor for undergoing Super-speciality course in Gastroenterology, subject to the condition, that the study period will be decided separately as per standing rules;

AND WHEREAS, the doctor after completion of the DNB course, rejoined in the Directorate of Health Services, Kashmir on 05.04.2018 and the services of the doctor are being utilized at District Hospital Baramulla by Directorate of Health Services, Kashmir;

AND WHEREAS, Directorate of Health Services, Kashmir has forwarded the case of the doctor to Administrative Department for further instructions;

AND WHEREAS, the instant case has been examined in consultation with Director Finance, Health & Medical Education Department (Chairman Departmental Designated Committee), and the department while taking considerate view in the matter, in the interest of patient care, decided to treat period of undergoing DNB Gastroenterology at Apollo Hospital Kolkata w.e.f. 12.03.2015 to 04.04.2018 in favour of Dr. Parvaiz Ahmad Shah, Medical Officer, as leave whatever kind due expect study leave and remaining period of short fall be treated as "Dies-Non", subject to the condition that the said doctor was not involved in any subversive activities as well as not employed in any private sector for which an affidavit duly authenticated by the 1st Class judicial Magistrate Besides, the action taken by Directorate of Health Services Kashmir with regard to utilization his services on rejoining be



also confirmed. Moreso, the concerned doctor shall be warned not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice.

Now, therefore, sanction is hereby accorded to:-

- i. treat period of undergoing DNB Gastroenterology at Apollo Hospital Kolkata w.e.f. 12.03.2015 to 04.04.2018 in favour of Dr. Parvaiz Ahmad Shah, Medical Officer, as leave whatever kind due expect study leave and remaining period of short fall be treated as "Dies-Non" and subject to the condition that the said doctor was not involved in any subversive activities as well as not employed in any private sector for which an affidavit duly authenticated by the 1st Class judicial Magistrate Besides, the action taken by Directorate of Health Services Kashmir with regard to utilization his services on rejoining is also confirmed.

Moreso, the concerned doctor is **warned** not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action will be initiated against him without any further notice.
