WHEREAS, Advisor(B) to Hon'ble Lieutenant Governor, J&K visited District Samba and paid surprise visit to various health institutions in the said District on 10-03-2020;

AND WHEREAS, Advisor(B) to Hon'ble Lieutenant Governor, J&K noticed various issues including shortage of Medical Officers at District Hospital Samba and directed for taking necessary action and submission of action taken report;


AND WHEREAS, Director Health Services, Jammu was requested to submit the details of sanctioned strength viz-a-viz in-position details of Medical Officers in DH Samba and was also requested to submit suitable proposal for posting of Medical Officers in DH Samba against all such vacancies;

AND WHEREAS, report furnished by Directorate of Health Services, Jammu revealed that the sanctioned strength of Medical Officers is 06 out of which only 04 are posted and out of which one of the doctor is looking after the work of Blood Bank;

AND WHEREAS, Directorate of Health Services, Jammu further reported that Dr. Chander Rashmi Gupta, Medical Officer has not joined till date as she was supposed to join in pursuance of Government Order No. 91-JK(HME) of 2019 dated 30-12-2019 and was deemed relieved in said order itself;

AND WHEREAS, vide, Government Order No. 91-JK(HME) of 2019 dated 30-12-2019 among others, Dr. Chander Rashmi Gupta, Medical Officer was transferred from Police Hospital, Jammu and posted at District Hospital, Samba and all the doctors in the said Government Order were deemed to have been relieved from their respective place of postings;

AND WHEREAS, Dr. Chander Rashmi Gupta, Medical Officer did not bother to join at her new place of posting i.e. District Hospital Samba, hampering the patient & health care facilities in District Samba.



Now therefore, it is hereby ordered that:

- i. pending enquiry, Dr. Chander Rashmi Gupta, Medical Officer is hereby placed under suspension with immediate effect, in terms of Rule 31 of the Jammu & Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. During the period of her suspension, Dr. Chander Rashmi Gupta, Medical Officer shall remain attached with the office of Medical Superintendent, District Hospital Samba.
- ii. Director Health Services, Jammu shall initiate disciplinary proceedings by conducting a formal enquiry against Dr. Chander Rashmi Gupta, Medical Officer for non compliance of Government Order No.91-JK(HME) of 2019 dated 30-12-2019 and submit the report to Administrative Department within 10 days positively.


