Notice

WHEREAS, vide Government Order No.592-HME of 2011 dated 28.10.2011 you were appointed as Medical Officer in the Health and Medical Education Department;

AND WHEREAS, subsequently you were deputed for undergoing Registrarship in GMC, Jammu;

AND WHEREAS, on completion of Registrarship in GMC, Jammu you were relieved to report in the Directorate of Health Services, Kashmir, pursuant to which you joined in the Directorate of Health Services, Kashmir on 07.10.2017. Subsequently, you were posted at CHC, Zainpora by the Director, Health Services, Kashmir vide Order No.Es-3/1-133/2905-08 dated 16.10.2017;

AND WHEREAS, after submitting the joining report in the Directorate of Health Services Kashmir, you neither turned up in the Directorate of Health Services Kashmir nor joined at the place where you were posted viz CHC-Zainpora, thereby resorting to un-authorized absence from duties;

AND WHEREAS, a notice was served on you by the Directorate of Health Services Kashmir, vide No.Est./3/1-133/3361-64 dated 13.11.2017, wherein opportunity was given to you to report back for your duties at CHC Zainpora, within five days from the date of issuance of the notice, failing which it shall be presumed that you are not interested to serve in the department anymore and action as warranted under Article 128 of J&K CSR shall be initiated against you for resorting to un-authorized absence;

AND WHEREAS, you did not report at your new place of posting & instead you sent an application on 26.12.2017 in the Directorate of Health Services Kashmir, through post, wherein it was stated that after completion of Registrarship, you applied for short-term fellowship outside the State and finally requested for permission to complete the fellowship by ending 03/2018;

AND WHEREAS, on 3.2.2018 you again appeared in the office of Directorate of Health Services, Kashmir with an application stating therein that you have left

the course prematurely and requested for allowing you to join, pursuant to which, pending decision about the period of your absence, you were allowed to join and posted at SDH Pattan, vide order No.Est/3/1-133/580-83 dated 16.02.2018, issued by the Director Health Services Kashmir;

AND WHEREAS, while being posted at SDH Pattan, the BMO Pattan, vide letter dated 09.04.2018, reported that you have again resorted to un-authorized absence from 28.03.2018 for which notice was served on you by BMO Pattan, vide letter dated 31.03.2018, asking you to report back at SDH Pattan but instead of joining back there you requested for grant of study leave and proceeded for fellowship course in Trauma and Ortho Surgery outside the country at London;

AND WHEREAS, all this shows that you are not interested to serve in the Department and are playing hide and seek with the Department just to keep your service intact, that too at the cost of health of poor patients of the State.

Now, therefore, final show cause notice is hereby served upon you and last and final opportunity is given to you to report back in the Directorate of Health Services, Kashmir, within a period of 15 days from the date of issue of this notice, failing which it shall be presumed that you have nothing to say in your defence and disciplinary proceedings under Article 128 of J&K Civil Service Regulations shall be initiated against you, without any further notice.
