Whereas, vide Govt. Order No. 68-HME of 2015, dated 23-03-2015 Dr. Nitin Kudyar was engaged as Lecturer, Periodontics in Indira Gandhi Govt. Dental College, Jammu on academic arrangement basis, for a period of one year in terms of SRO-384 of 2009 dated 14-12-2009 or till the post is filled up as per J&K Dental Education (Dental College) Gazetted Service, Recruitment Rules, 1993; and

Whereas, Principal Dental College, Jammu vide communication dated 06-05-2015 has intimated that the said doctor has not joined the Dental College within a period of 21 days from the date of issuance of engagement order and even not reported till 06-05-2015; and

Whereas, case has been examined in the department and vide this Department's letter dated 05-07-2015, the Principal, Indira Gandhi Govt. Dental College was advised to give one more opportunity to Dr. Nitin Kudyar, Lecturer, Periodontics, Indira Gandhi, Govt. Dental College, Jammu with defined number of days for joining the Dental College as Lecturer on academic arrangement basis in the discipline of Periodontics; and

Whereas, the Principal, Indira Gandhi Govt. Dental College, Jammu intimated vide communication No. IGGDCJ/Estt/GD/Acad/1237 dated 14-09-2015 that Dr. Nitin Kudyar was given one more opportunity to join his duties within 21 days vide his office letter No IGGDCJ/Estt/GD/Acad/1175-76 dated 07-09-2015; and

Whereas, as reported by the Principal Indira Gandhi Govt. Dental College vide communication No. IGGDCJ/Estt/GD/Acad/1645 dated 28-10-2015 that Dr. Nitin Kudyar did not join even after having been given one more opportunity within the stipulated time period.

Now, therefore, the engagement of Dr. Nitin Kudyar, as Lecturer, Periodontics in Indira Gandhi Govt. Dental College, Jammu on academic arrangement basis issued vide Govt. Order No. 68-HME of 2015, dated 23-03-2015 is hereby cancelled ab-intio.
