Whereas, the Jammu and Kashmir Health and Family Welfare (Gazetted) Services Recruitment Rules were issued in the year 1992 vide SRO-20 dated 24-02-1992; and

Whereas, as reported by the Director Family Welfare, MCH & Immunization J&K the post of Cold Chain Officer (Non-Gazetted) services is existing in the department and was created in the year 1986; and

Whereas, the existing Jammu and Kashmir Health and Family Welfare (Subordinate) Services Recruitment Rules notified in the year 1992 do not have any provision for filling up of said post; and

Whereas, the said post are lying vacant in the department due to non availability of the recruitment rules; and

Whereas, no rules is in force to determine the "Method of Recruitment" of the said post required for the establishment of Immunization programme in the Health and Family Welfare Department; and

Whereas, vide letter No. DFW/J.K/Est-TA/14/1683 dated 27-06-2014 the Director, Family Welfare, MCH & Immunization J&K, Srinagar has recommended the proposed draft recruitment rules of in-question post. After examining the said proposal, it has been decided to prescribe the method of recruitment rules of the said posts, till Recruitment Rules for the post are finalized.

Now, therefore, it is ordered that the method of recruitment for filling up of the posts of Cold Chain Officer (Non-Gazetted) services in Directorate of Family Welfare Department shall be as under.
