The appointees shall report to the Director, Health Services, Kashmir/Jammu for further duties, who shall allow them to join on production and verification of the following certificates (in original): -

- i) Date of birth Certificate.
- ii) Permanent Residence Certificate (PRC)
- iii) Qualification Certificate
- iv) Character Certificate.

Salary of the appointees shall not be drawn and disbursed unless satisfactory report regarding their character and antecedents is received from the Distt. Magistrate concerned/CID, to whom a reference shall be made by the Director, Health Services, Kashmir/Jammu. In case of adverse report, the appointees shall have no claim on the appointment, which shall be deemed to have been cancelled ab-initio, without further notice.




