Sanction is hereby accorded to the temporary appointment of Mr. Mohammad Saleem Sheikh S/o Late Altaf Hussain Sheikh (Ex- Safaiwala) R/o Donipawa, Tehsil Anantnag, District Anantnag, as Safaiwala, in the Pay Band of Rs. 4440-7440 with the Grade Pay of Rs. 1300/- in the Directorate of Health Services Kashmir, in relaxation of the prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Director, Health Services, Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates:-

1. Academic qualification certificates
2. Age and Health Certificate
3. Permanent Resident Certificate
4. All other relevant documents as are required under SRO 43 of 1994.
5. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report regarding his character and antecedents is received from District Magistrate concerned/CID to whom a reference shall be made by the Director, Health Services, Kashmir. In case of adverse report, the appointee shall have no claim on the appointment, which shall be deemed to have been cancelled ab-initio, without any notice.

If on verification, the certificates produced by the appointee prove fake or forged, his appointment shall be treated as cancelled ab-initio.




