As recommended by the Empowered Committee constituted under Section 10 of J&K, Civil Services (Special Provisions) Act, 2010, sanction is hereby accorded to the regularization of Mr. Gurcharan Singh S/o S. Teja Singh R/o Gol Gujral, Jammu (Adhoc employee) against the post of Sanitary Inspector in the Pay Band of Rs. 9300-34800 with Grade Pay of Rs 4260/- in the Directorate of Health Services, Jammu, in relaxation of upper age limit by 12 years 11 months and 16 days.

The appointee shall be on probation for a period of two years. His inter-se seniority shall be determined in terms of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

The appointee shall report to the Director, Health Services, Jammu for further duties, who shall allow him to join on production and verification of the following certificates (in original): -

- i) Date of birth Certificate.
- ii) Permanent Residence Certificate (PRC)
- iii) Qualification Certificate
- iv) Character Certificate

Salary of the appointee shall not be drawn and disbursed unless satisfactory report regarding his character and antecedents is received from the Distt. Magistrate concerned/CID, to whom a reference shall be made by the Director, Health Services, Jammu. In case of adverse report, the appointee shall have no claim on the appointment, which shall be deemed to have been cancelled ab-initio, without further notice.

If, on verification at any time, the certificates produced by the appointee prove fake or forged, his appointment shall be treated as cancelled ab-initio.


