Subject: Selection for the post of Consultant (Radiology) in the Health and Medical Education Department – waiting list.

Whereas, vide Government order No.746-HME of 2015 dated:02-12-2015, appointment of Dr. Mohmed Tufail Sheikh S/O Gulam Hassan Sheikh R/o H-112, Lane 01, Sector-01, Sir Syedabad Bemina, Srinagar, under open merit category, as Consultant (Radiology) was cancelled ab-initio due to his non-joining;

And whereas, in the said Government order, Secretary, J&K, Public Service Commission was requested to furnish the waiting list in the said category;

And whereas, J&K Public Service Commission vide reference No.PSC/DR/Consultant/Radiology/2014 dated:04-12-2015 intimated the name of Sheikh Shahnawaz Sultan S/o Mohammad Sultan Sheikh R/o Mustafa Abad-B Lane-03 Old Zainakote Road HMT, Srinagar being next in the order of merit under OM category, and recommended him for appointment as Consultant in the discipline of Radiology in the Health & Medical Education Department having secured 74.75 marks in aggregate;

Now, therefore, as recommended by the J&K, Public Service Commission, sanction is hereby accorded to the appointment of Sheikh Shahnawaz Sultan S/o Mohammad Sultan Sheikh R/o Mustafa Abad-B Lane-03 Old Zainakote Road HMT, Srinagar, on regular temporary basis, as Consultant (Radiology) in the Pay Band of Rs.15600-39100 with Grade Pay of Rs.6600/- in the Health (Gazetted) Services.

The appointee shall report to Directorate of Health Services, Kashmir for the purpose of joining. The concerned Director shall allow him to join only after verification of his following certificates, in original:

1. Academic/Professional eligibility qualification certificates.
2. Internship Completion certificate from any recognized Institution.
3. State/Central Registration Certificate.
4. Permanent Resident Certificate.
5. Certificates from the concerned authorities to the effect that no loan under self employment scheme has been taken by the appointee.
6. Date of Birth Certificate.
7. Medical Fitness Certificate.

The above appointment shall further be subject to the following conditions:

- i- that the appointee will report for duty within a period of 21 days from the date of issue of this order, failing which his appointment will be treated as cancelled ab-initio without any further notice. The joining time shall not be extended in any circumstances.



- ii- that the appointee shall be on probation for a period of two years as per the Jammu & Kashmir Health and Family Welfare (Gazetted) Service Recruitment Rules, 2013 read with the Jammu and Kashmir Civil Services (Classification, Control & Appeal) Rules, 1956.
- iii- the appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the Director, Health Services, Kashmir, the candidate shall have no right to claim his appointment and his appointment as such shall be deemed to have cancelled ab-initio.
- iv- verification/genuineness of the qualification certificates, from the concerned issuing authorities.
- v- that, if on verification, the certificates /documents produced by the candidate are proved fake or forged, the appointment shall be cancelled ab-initio.
- vi- the inter-se-seniority shall be in accordance with merit position assigned to him by the J&K Public Service Commission.
- vii- that appointment is subject to outcome of writ petition pending, if any, before any competent court of law on the subject.
- viii- that the salary of the above named appointee shall not be drawn and disbursed unless and until satisfactory character and antecedents / verification/genuineness of the qualification certificates is received.


