As recommended by the Empowered Committee constituted vide Government Order No. 1423-GAD of 2009 dated 14-10-2009, sanction is hereby accorded to the regularization of Ms. Saleema D/o Mohd Akbar Ganie R/o Uri, Baramulla against the post of FMPHW in the Pay Band of Rs 5200-20200 with Grade Pay of Rs 1900/- in the Directorate of Health Services, Kashmir, in relaxation of upper age limit by 06 years and 07 months in terms of J&K Civil Services (Special Provision) Act, 2010

The appointee shall be on probation for a period of two years. Her inter-se seniority shall be determined in terms of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

The appointee shall report to the Director, Health Services, Kashmir for further duties, who shall allow her to join on production and verification of the following certificates (in original): -

- i) Date of birth Certificate.
- ii) Permanent Residence Certificate (PRC)
- iii) Qualification Certificate
- iv) Character Certificate

Salary of the appointee shall not be drawn and disbursed unless satisfactory report regarding her character and antecedents is received from the Distt. Magistrate concerned/CID, to whom a reference shall be made by the Director, Health Services, Kashmir. In case of adverse report, the appointee shall have no claim on the appointment, which shall be deemed to have been cancelled ab-initio, without further notice.

If, on verification at any time, the certificates produced by the appointee prove fake or forged, her appointment shall be treated as cancelled ab-initio.


