As recommended by the J&K Public Service Commission vide its above referred communication, sanction is hereby accorded to the regular temporary appointment of Shri Parvaiz Anwar Rather S/o Sh. Mohd Anwar Rather R/o Khaipora P/o Kreeri Tehsil Tangmarg, District Baramulla, Kashmir as Lecturer in the discipline of Dermatology in Government Medical College, Jammu, under Open merit Category in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 5400/-

The appointee shall join the department within a period of 21 days from the date of issue of this order and in case he does not join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be on probation for a period of two years and confirmation of the appointee in the service shall be regulated under the provisions of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

The Principal, Govt Medical College, Jammu shall allow the appointee to join only on production of the following document/certificates:-

- a). Date of birth Certificate
- b). Qualification Certificate.
- c). No Loan Certificate from the DIC/Employment Department.
- d). State Subject Certificate.
- f). Health Certificate from the Standing Medical Board.
- g). Any other documents as required under rules

The salary of the appointee shall not be drawn & disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID to whom a reference shall be made by the Principal, Govt Medical College, Jammu. He shall be allowed to join on production of an affidavit on the specified format.

In case the candidate is adversely reported upon by the verifying agency or if on verification, the certificates produced by the appointee are proved to be fake or forged, his appointment shall be cancelled ab-intio without any further notice.

The interim arrangement, if any made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.

The appointment of the candidate is subject to the outcome of the writ petition(s), if pending, in any court of competent jurisdiction.


