The appointees shall be on probation for a period of two years. Their inter-se seniority shall be determined in terms of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

The appointees shall report to the Director, Health Services, Kashmir for further duties, who shall allow them to join on production and verification of the following certificates (in original): -

- i) Date of birth Certificate.
- ii) Permanent Residence Certificate (PRC)
- iii) Qualification Certificate
- iv) Character Certificate.

Salary of the appointees shall not be drawn and disbursed unless satisfactory report regarding their character and antecedents is received from the Distt. Magistrate concerned/CID, to whom a reference shall be made by the Director, Health Services, Kashmir. In case of adverse report, the appointees shall have no claim on the appointment, which shall be deemed to have been cancelled ab-initio, without further notice.

If, on verification at any time, the certificates produced by the appointee (s) prove fake or forged, their appointment shall be treated as cancelled ab-initio.


