Whereas, on the recommendations of J&K Public Service Commission conveyed vide letter No. PSC/DR/AP Microbiology/2018 dated 24.10.2018, , vide Govt Order No.633-HME of 2018 dated 20.11.2018, Peer Maroof Ahmad S/O Peer Siraj Ud Din C/O Department of Microbiology, GMC Srinagar was appointed as Assistant Professor (Lecturer) in the discipline of Microbiology under Open Category in Govt Medical College Anantnag; and

Whereas, after issuance of formal appointment order, Principal, GMC, Anantnag vide his letter No. P/GMC/Ang/Kmr/18/313 dated 13.12.2018 intimated that Peer Maroof Ahmad has submitted an application wherein he has stated that he is not interested in joining the said post and requested for operation of the waiting list; and

Whereas, the case was examined afresh in view of the communication from Principal, GMC, Anantnag and accordingly Secretary, J&K PSC vide this department's letter No. ME-Gaz(New GMC)/19/2018 dated 26.12.2018 was requested for furnishing wait list for the post of Assistant Professor (Lecturer) in the discipline of Microbiology in GMC, Anantnag under OM Category against the vacancy caused due to non joining of Dr. Peer Maroof Ahmad; and

Whereas, the J&K PSC vide letter No. PSC/DR/AP Microbiology/2018 dated 04.02.2019 has now recommended another candidate for appointment as Assistant Professor, Microbiology in GMC, Anantnag.

Now, therefore, the appointment of Peer Maroof Ahmad as Assistant Professor (Lecturer) Microbiology under Open category in Government Medical College, Anantnag ordered vide Government Order No. 633-HME of 2018 dated 20.11.2018, is hereby cancelled ab-initio.


