As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of the following candidates against the post of Assistant Professor (Lecturer) in the Discipline of General Surgery in Government Medical College, Anantnag in the Pay Band of Rs. 15600-39100 + GP Rs. 6600/- (Pre Revised), now revised to Level-11 (67700-208700), with immediate effect:-

The above candidates shall report to the Principal, Government Medical College, Anantnag within a period of 21 (twenty one) days from the date of issuance of this appointment order. In case of failure of the appointees to join within the stipulated period, their appointment shall be deemed to have been cancelled without any further notice.

The appointees shall be allowed to join only on production of the following documents/certificates in original:-

1. Date of Birth Certificate.
2. Qualification Certificates.
3. Certificate from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
4. State Subject Certificate.
5. Health Certificate from the Standing Medical Board.
6. Reserved Category Certificate (where applicable).
7. Any other documents as required under rules.

The appointment of the above candidates as Assistant Professor (Lecturer) shall further be subject to the following conditions:-

- i) Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his Character and

Antecedents is received from the Additional Director General of Police, (CID), J&K, to whom a reference shall be made by the Principal, Government Medical College, Anantnag, he shall have no right to claim his appointment, as such, and his appointment shall be deemed to have been cancelled *ab-initio*.

- ii) Verification/genuineness of the qualification certificates and reserved category certificate (where applicable) from the concerned issuing authorities.

The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.

The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

The appointees shall be on probation for a period of two (02) years and their confirmation shall be made under the provisions of J&K Civil Services (Classification, Control and Appeal) Rules, 1956. The inter-se-seniority of the appointee(s) shall be in accordance with the merit secured by them in the selection list prepared by the J&K Public Service Commission.

The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.

The appointment shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.


