As recommended by the Empowered Committee and in terms of the Jammu and Kashmir Civil Services (Special Provision) Act, 2010, sanction is hereby accorded to the regularization of services of Ms. Latifa Akhtar (Contractual FMPHW) D/o Mr. Abdul Samad Shah R/o Dahermona, Budgam as FMPHW in the Health & Medical Education Department in the pay scale of Rs. 5200-20200 with Grade Pay of Rs. 1900 (Pre-Revised) prospectively.

The appointee shall be on probation for a period of two years. Her inter-se-seniority shall be determined in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

The appointee shall report to the Director, Health Services, Kashmir for further duties, who shall allow her to join only on production of the following certificates/documents (in original):-

- iii. Qualification Certificate.
- iv. Category Certificate (if any).
- v. Character Certificate.



The Salary of the above appointee shall not be drawn and disbursed unless a satisfactory report regarding her character and antecedents is received from the District Magistrate concerned/CID, to whom a reference shall be made by the Director, Health Services, Kashmir. In case of adverse reporting, the appointee shall have no claim on the appointment and her service shall be deemed to have been cancelled ab-initio, without further notice.

If on verification at any time, the certificates produced by the appointee is proved fake or forged, her appointment shall be treated as cancelled ab-initio.
