As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of the following candidate against the post of Assistant Professor (Lecturer) in the Discipline of Ophthalmology in Government Medical College, Baramulla in the Pay Band of Rs. 15600-39100 + GP Rs. 6600/- (Pre Revised), now revised to Level-11 (67700-208700), with immediate effect:-

The above candidate shall report to the Principal, Government Medical College, Baramulla within a period of 21 (twenty one) days from the date of issuance of this appointment order. In case of failure of the appointee to join within the stipulated period, her appointment shall be deemed to have been cancelled without any further notice.

The appointee shall be allowed to join only on production of the following documents/certificates in original -

1. Date of Birth Certificate.
2. Qualification Certificates.
3. Certificate from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
4. State Subject Certificate.
5. Health Certificate from the Standing Medical Board.
6. Any other documents as required under rules.

The appointment of the above candidate as Assistant Professor (Lecturer) shall further be subject to the following conditions:-

- i) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about her Character and Antecedents are received from the Additional Director General of Police, (CID), J&K, to whom a reference shall be made by the Principal, Government Medical College, Baramulla, she shall have

- no right to claim her appointment, as such, and her appointment shall be deemed to have been cancelled *ab-initio*.
- ii) Verification/genuineness of the qualification from the concerned issuing authorities.

The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory reports in respect of (i) and (ii) above are received in her favour.

The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

The appointee shall be on probation for a period of two (02) years and her confirmation shall be made under the provisions of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.

The appointment shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.


