Subject: Termination of services of doctors.

Government Order No. 654 -HME of 2019
Dated: 10 .07.2019

WHEREAS, vide letter No. HME/HRM/179/2017 dated 10.12.2018, the Directorate of Health Services, Jammu/Kashmir were requested to furnish lists of such doctors viz. Consultants/Medical Officers/Dental Surgeons etc, who are on un-authorized absence from duties, also indicating the dates from which they are absent;


2. AND WHEREAS, the Directors, Health Services, Jammu/Kashmir vide communications No. ES-3/Notice/480-17 dated 25.03.2019 and No. Est/3/1-133/8396 dated 12.03.2019 respectively forwarded the lists of such doctors who are un-authorizedly absent from duties;


3. AND WHEREAS, the Directors, Health Services, Jammu/Kashmir informed that they have already served notices to these doctors who are on unauthorized absence, wherein an opportunity was given to them to report back to their duties;

4. AND WHEREAS, the matter was examined in the Health and Education Department and it was decided to give a final opportunity to these absentee doctors to rejoin their duties in their respective Directorates;

5. AND WHEREAS, the Health & Medical Education Department accordingly issued notices to these doctors asking them to join their duties in their respective Directorates i.e. Directorate of Health Services, Jammu/Kashmir within 15 days from the date of issuance of notices, failing which it shall be presumed that they have nothing to say in their defence and proceedings as warranted under Article 128 of J&K Civil Services Regulations shall be initiated against them, which inter-alia, provides that absence without leave or after the end of leave involves loss of appointment;

6. AND WHEREAS, the Director, Health Services, Kashmir furnished a list of following nine (9) doctors intimating that they have not resumed their duties

AND WHEREAS, the cases of aforementioned doctors presently on unauthorized absence, have been examined thoroughly in the Department in light of the rule position governing the subject and it has been found that since these doctors have not resumed their duties despite repeated notices, this act on their part is a voluntary act and warrants initiation of necessary action against them in terms of Article 128 of J&K Civil Services Regulations;

Now, therefore, in light of the relevant rules and the circumstances explained hereinabove, the services of the above nine (09) doctors are hereby terminated with effect from the dates they are on unauthorized absence.






