Subject:- Final Notice in favour of Dr. Hilal Ahmad Dar, Assistant Professor (Lecturer) in the discipline of General Medicine, for resumption of duties in Government Medical College, Baramulla.

WHEREAS, on the recommendation of J&K Public Service Commission, conveyed vide their letter No. PSC/DR/AP(Lect)Gen.Med/HME/2018 dated 21.01.2019, among others, Dr. Hilal Ahmad Dar S/O Ab Ahad Dar R/O Khaja Gilgit Sopore, Baramulla was appointed as Assistant Professor (Lecturer) in the discipline of General Medicine in Government Medical College, Baramulla, vide Government Order No. 160-HME of 2019 dated 08.02.2019, subject, among other conditions, to the condition that the appointee shall report to the Principal, Government Medical College, Baramulla within a period of 21 (twenty one) days from the date of issuance of the appointment order and in case of failure to do so, his appointment shall be deemed to have been cancelled without any further notice;

AND WHEREAS, the aforesaid doctor joined as Assistant Professor (Lecturer) in the Department of General Medicine in Government Medical College, Baramulla on 26.02.2019;

AND WHEREAS, the aforesaid doctor approached the Administrative Department for approval to continuation of study leave, already sanctioned in his favour by the Health & Medical Education Department vide letter No. HD(Gaz)Gen-28/2015 dated 28.07.2016;

AND WHEREAS, the matter has been examined in the Department and it has been decided that in keeping with the policy of the Department in such cases, Dr. Hilal Ahmad Dar, may choose as to whether he would like to continue with his higher studies or would opt for his new appointment in Government Medical College, Baramulla;

AND WHEREAS, before taking further necessary action in the matter, it has been decided to give a final opportunity to the aforesaid doctor to resume his duties in Government Medical College, Baramulla.

Now, therefore, Dr. Hilal Ahmad Dar S/O Ab Ahad Dar R/O Khaja Gilgit Sopore, Baramulla, appointed as Assistant Professor (Lecturer) in the discipline of General Medicine, in Government Medical College, Baramulla, is afforded a final opportunity to resume his duties within a period of seven (07) days from the date of issuance of this order, failing which it will be presumed that he is not interested in complying with this final notice and his appointment made vide Government Order No. 160-HME of 2019 dated 08.02.2019 shall be treated as cancelled *ab-initio* without any further notice.
