Subject: Application of doctors for rejoining & postings thereof.

WHEREAS, the Director, Health Services, Kashmir vide communication No. Est/3/1-133/803 dated 19-06-2019 has intimated that 26 doctors have reported in their Directorate after completion of their higher study courses (with/without permission of Administrative Department);

AND WHEREAS, the services of 05 doctors are being utilized by the Director, Health Services, Kashmir in different Hospitals, pending confirmation from Administrative Department and some doctors are awaiting instructions from Administrative Department with regard to their settlement of absence period or allowing of joining;

AND WHEREAS, the instant case has been examined in consultation with the Director Finance, Health & Medical Education (Chairman, Departmental Designated Committee) and the department while taking a lenient view submitted a proposal for confirmation of action taken by the Director, Health Services, Kashmir by allowing re-joining/utilization of services of 05 doctors pending settlement of their absence period and acceptance of re-joining of all other 21 doctors notionally from the date they have reported in the Directorate of Health Services, Kashmir and monetarily with immediate effect and issuance of their posting orders in the interest of patient care and the same has been approved by the competent authority.

Now, therefore, in the interest of patient care, sanction is hereby accorded to the:-
