As recommended by the Empowered Committee, sanction is hereby accorded, in terms of Jammu & Kashmir Civil Services (Special Provisions) Act, 2010, to the regularization of services of Mst. Mahjabeen (Contractual FMPHW) D/o Abdul Ahad Bhat R/o Dangerpora Chattergam as FMPHW in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs. 1900/- in the Health Department, against an available post, on prospective basis.

The appointee shall be on probation for a period of two years. Her inter-seniority shall be determined in terms of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

The appointee shall report to the Director, Health Services, Kashmir for further duties, who shall allow her to join only on production of the following certificates/documents (in original):-

1. Permanent Residence Certificate (PRC).
2. Date of Birth Certificate.
3. Qualification Certificate.
4. Category Certificate (if any).
5. Character Certificate.

The Salary of the above appointee shall not be drawn and disbursed unless a satisfactory report regarding her character and antecedents is received from the District Magistrate concerned/CID, to whom the reference shall be made by the Director Health Services, Kashmir. In case of adverse reporting, the appointee shall have no claim on the

appointment and her service shall be deemed to have been cancelled ab-initio, without further notice.

If on verification at any time, the certificates produced by the appointee are proved fake or forged, her appointment shall be treated as cancelled ab-initio.


